# WAR, AGGRESSION AND SELF-DEFENCE

Yoram Dinstein

*Professor of International Law and Yanowicz Professor of Human Rights, Tel Aviv University*

This book re-examines the topics of war, aggression and self-defence, as well as related issues, such as collective security and the use of force short of war.

The first part deals with such questions as: What is war? When does it commence and terminate? What is the difference between peace treaties, armistice agreements and cease-fires? Where can war be waged and what is the meaning of neutrality?

The focus of the discussion in the second part is the contemporary prohibition of the use of force and its standing as *jus cogens*. The meaning of aggression is explored. The concept of crimes against peace, which evolved in the *Nuremberg* trial, is examined. Some controversial implications of the illegality and criminality of war are analyzed.

The third part explores the concept of self-defence. The scope of armed attack, prior to the exercise of the right of self-defence, is investigated, distinguishing between attacks launched by a foreign State and those that are carried out from its territory by armed bands. Special attention is given to such disputed points as the legality of armed reprisals and the protection of nationals abroad.

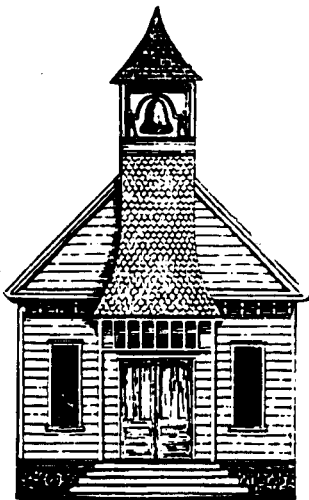

This information will be the basis of a user's guide to the software.

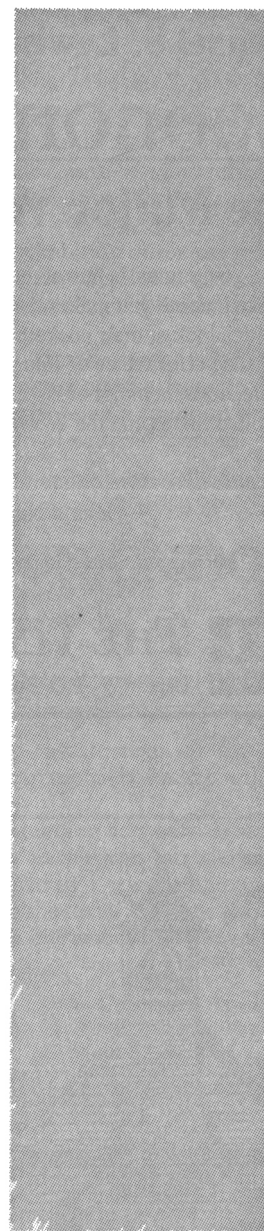

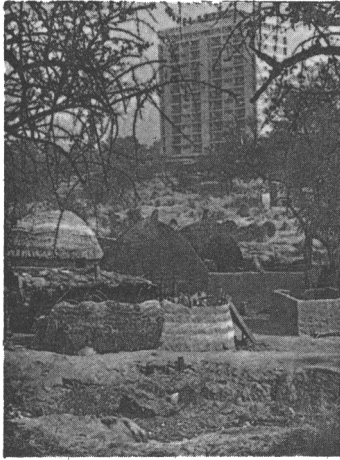

# APSA Research Grant Program

The Council of the American Political Science Association  
announces the 1989 small grant program to  
support research in all fields of Political Science.

## ***Scope of Award***

Projects should address a significant problem in political science. Proposals must state how the project relates to previous research and theoretical developments, and how the project contributes to scholarship within a field.

## ***Eligibility***

Applicants must be APSA members. In addition, the principal investigator must be one of the following:

- (a) a political science faculty member at a college or university that does not award a PhD in political science.
- (b) a political scientist not affiliated with an academic institution.

## ***Funding***

Grants will be awarded annually by the Committee on Research Support. The Council has made \$15,000 available for 1989 research grants. Individual grants will not exceed \$1,500 and are not renewable.

Funds may be used for such research activities as: travel to archives; travel to conduct interviews; administration and coding of survey instruments; and purchase of data sets. This list is merely illustrative, but specifically excluded from funding are: travel to professional meetings; secretarial costs except for the preparation of final manuscripts for publication; and salary support for the principal investigator.

## ***Format***

Proposals should be no more than five pages (single-spaced) with a budget and curriculum vitae attached.

Proposals must address all items under the scope of award and indicate the precise purpose for which the requested funds will be used. Any financial support the principal investigator is already receiving or anticipates receiving should be specified in the proposal.

# INSTRUCTIONS TO CONTRIBUTORS

---

The *American Political Science Review* aims to publish scholarly research and writing of exceptional merit. Contributions must demonstrate the highest standards of excellence in conceptualization, exposition, methodology, and craftsmanship. Because the *Review* reaches a diverse audience of scholars and practitioners, contributors must demonstrate how their analysis or exposition illuminates a significant research problem, or answers an important research question, of general interest in political science.

## Article Manuscripts

Article manuscripts should be submitted to the Managing Editor, Professor Samuel C. Patterson, *American Political Science Review*, Department of Political Science, Ohio State University, 112 Derby Hall, Columbus, Ohio 43210-1373. Four copies must be submitted, and none can be returned. Manuscripts must be typed double-spaced, on only one side of the paper. The author's name and affiliation should not appear on the copies submitted, but only on a separate covering sheet. An abstract of no more than 150 words must be sent with the manuscript. In general, the *Review* considers manuscripts of up to 30 pages in length. Moreover, the *Review* does not consider manuscripts submitted to other publications.

Manuscripts should be prepared following the guidelines of the *Style Manual for Political Science*, a publication of the American Political Science Association's Committee on Publications. It is available from the association's office. Otherwise, authors should follow the *Chicago Style Manual* and the example of recent issues of the *Review*. Graphs and tables should be presented on separate pages, with their location in the manuscript indicated, e.g., the notification "Table 1 about here," at the proper places.
