## PROFILES

**EARLE C. FERGUSON** has been appointed director of libraries for the University of Manitoba, Winnipeg. 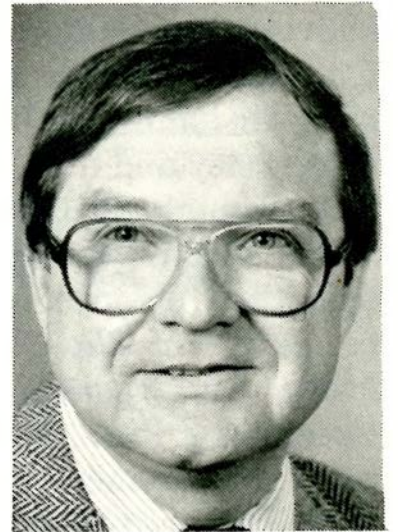

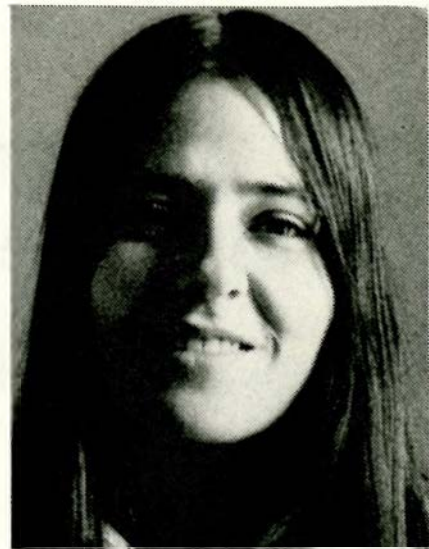

SILVI TREIER retired from the position of senior assistant cataloger in the Materials Acquisition Department of the University of Calgary, Alberta, on June 30th.

GERHARD VASCO is retiring September 21 as coordinator of collection development and interim assistant director for technical services at the State University of New York, Stony Brook.

ROBERT VOSPER retired this summer from his position as professor in the University of California, Los Angeles, Graduate School of Library and Information Science. He retains the title of university librarian and professor emeritus.

Vosper came to UCLA in 1944 to serve as head of the Acquisitions Department after serving briefly on the library staff of the University of California, Berkeley, and Stanford University. He was director of libraries at the University of Kansas in 1952-1961, but returned to UCLA as university librarian from 1962 to 1973, and as professor until this year. He also served as director of UCLA's William Andrews Clark Memorial Library from 1966 to 1981.

Vosper was awarded bachelor's and master's degrees in classics from the University of Oregon in 1937 and 1939. He then went to Berkeley for his certificate in librarianship in 1940. In 1967 Hofstra University awarded him the honorary LL.D.

An active member of ALA, Vosper was ACRL's 18th president in 1955-1956 and president of ALA in 1965-1966. He also served as chairman of the Association of Research Libraries in 1963 and as vice president of the International Federation of Library Associations in 1971-1977. In 1974 the Library Association of Great Britain named him an honorary vice president, and in 1977 IFLA appointed him an Honorary Fellow and he was awarded the medal of an officer in the Order of the Crown of Belgium.

The international scope of his career is marked also by service as a member of the U.S. National Commission to UNESCO in 1968-1973 and of the

U.S. State Department's Government Advisory Committee on International Book and Library Programs in 1970-1976. Earlier he had investigated the growth of modern British university libraries as a Guggenheim Fellow in 1959-1960, and in the spring of 1960 he served the United States Information Service as a Fulbright Senior Lecturer, speaking on modern library developments at universities throughout Italy. In 1973-1974 he returned to England as Honorary Research Fellow in the Library School of University College, London, and during the same year again served USIS as lecturer in library schools in Scandinavia.

In this country Vosper has served as consultant or advisor to the American Chemical Society (*Chemical Abstracts*), the American Council of Learned Societies, the Bibliographical Society of America, the National Aeronautics and Space Administration, the National Library of Medicine, and the National Science Foundation. Since 1968 he has been a member of the Board of Directors of the Council on Library Resources. Over the years Vosper has written or edited over 140 professional books and articles.

PAUL W. WINKLER, senior descriptive cataloging specialist in the Office for Descriptive Cataloging Policy, retired on June 24 after 20 years of service with the Library of Congress.

## DEATHS

C.F.W. (FRED) COKER, head of the Reference and Reader Service Section of the Library of Congress Manuscript Division since 1978, died of cancer on June 20. He was assistant state archivist (1963-1970) and state archivist (1970-1973) in the North Carolina Department of Archives and History, Raleigh, before joining the staff of the National Archives and Records Service, where from 1974 to 1978 he was in charge of the Printed Documents Division. While at the Archives he served as director of the Modern Archives Institute, associate editor and then editor of the *American Archivist*, and as editor for the Society of American Archivists basic manual series.

Coker received a Meritorious Service Award in 1981 for his plan to relocate the manuscript collections from LC's John Adams Building, and the following year he served as chair of SAA's Philip M. Hamer Award Committee, established to recognize the efforts of new and relatively inexperienced editors.

JOSEPHINE M. COWLES, associate professor emeritus and head of the Catalog Department at Wichita State University, Kansas, died on July 26. After her retirement in 1976, Cowles returned to the library to help with the cataloging of rare books. She received her bachelor's degree from Ottawa University and her MLS from the University of Illinois.



DAVID G. ESPLIN, book selection and acquisitions librarian at the University of Toronto Library, died after a long illness on July 10.

ANDREW H. HORN, dean of the University of California, Los Angeles, School of Library and Information Science from 1959–1978, died on May 25. He also served as collection librarian at Occidental College (1957–1959), university librarian at the University of North Carolina at Chapel Hill (1954–1957), and assistant associate university librarian (1951–1954), archivist (1950–1957), and assistant head of the Department of Special Collections (1948–1951) at UCLA. Horn held a Ph.D. in history from UCLA and a degree in librarianship from the University of California, Berkeley.

JANE R. MORHARDT, assistant librarian at Harvard's Lamont Library, died on May 29. She had served at Lamont Library for 15 years.

ADAH MAY OBENHAUS, chief cataloging librarian at Southwest Texas State University, San Marcos, died on April 19, after eighteen years of service at that library.

JAY RASIEL, of the Science and Engineering Library, State University of New York, Buffalo, died on June 23.

HERMAN F. ROBINSON, curator emeritus and former business librarian of the New York University Graduate School of Business Administration, died on March 7.

GEORGE H. VROOMAN, humanities bibliographer at the Yale University Library since 1966, died on June 12.

CONSTANCE M. WINCHELL, author of the 7th (1951) and 8th (1967) editions of *Guide to Reference Works*, died on May 23 at the age of 86. Winchell joined the staff of the Columbia University Libraries in 1925 as a reference assistant and became chief reference librarian at Columbia in 1941. She held this position until her retirement in 1962. She had previously worked at the University of Michigan Libraries and the American Library in Paris. Long active in the American Library Association, Winchell was awarded the Isadore Gilbert Mudge Citation for distinguished service in 1960. ■■

# News from the Field

## ACQUISITIONS

•ILLINOIS STATE HISTORICAL SOCIETY Library, Springfield, has acquired a collection of the letters and manuscripts of U.S. Senator Lyman Trumbull (1813–1896) to add to their existing collection of Trumbull family papers. Included are letters from Trumbull and his brothers and sisters to family members in Jackson, Michigan, mostly dating from the 1840s and 1850s.

•NEW YORK PUBLIC LIBRARY has purchased a collection of important papers and documents by and about Herman Melville (1819–1891), including the first draft of a portion of the author's first published novel, *Typee* (1845), as well as hundreds of family letters and memorabilia. Other rarities are a fragment from the short story "Bartleby the Scrivener," three letters signed by Melville, and over 500 letters from Melville's mother, wife, and other family members. The collection also contains three large family trunks and other artifacts. New York Public Library possesses one of the largest collections of Melville material in the world.

•OKLAHOMA STATE UNIVERSITY Library, Stillwater, has received the papers of Paul Miller, now chairman emeritus of the Gannett Company. The papers, which record the beginnings and growth of news networks in America, include writings, photos, documents, news stories, and personal correspondence that reflect Miller's early career and his term as president of the Associated Press.

•THE PUBLIC ARCHIVES OF CANADA, Ottawa, recently acquired the historical papers of the Montreal Amateur Athletic Association. The collection, dating from 1861 to 1934, comprises minute books, annual reports, correspondence, posters, and souvenir programs. Established in 1881, the Association was important in the history of amateur sports in Canada.

•THE UNIVERSITY OF DENVER's Center for the Study of Library Architecture has received, as a gift from David Kaser, his architectural consultation papers, plans, and programs for the years 1958–1975. Kaser, a former president of ACRL, has advised in the development of over 60 college and university library buildings in the United
