

**Mark Coir** has been named the Wayne State University Library and Information Science Program's 1999 Distinguished Alumnus. Coir has been director of Archives at the Cranbrook Educational Community in Bloomfield Hills, Michigan, since 1983. Prior to his position at Cranbrook, he served as reference librarian at the Detroit Public Library and as an archivist for the Burroughs Corporation. Coir has served as a consultant to the Detroit Historical Society and the Detroit Medical Center. He recently stepped down as president of the Michigan Archival Association and continues to be active in the Society of American Archivists.

**Carol Anne Germain**, Networked Resources Education librarian at the University at Albany (UA), SUNY, and **Laura Horn**, a graduate student in the School of Information Science and Policy at UA, were this year's recipients of the Pritchard Award. The award is given in recognition of Germain's and Horn's joint project to develop a Web-based interactive tutorial for students to evaluate Internet information resources. The educational tool they developed will teach ways to evaluate resources accessed via the Internet and show students the importance of accessing resources appropriate to the task. Each of the recipients received \$500 and a certificate. The Pritchard Award was established by Miriam Snow Mathes in tribute to the life and work of Martha Caroline Pritchard, the first director of UA's Library School (1926-41).

**Simmona Simmons-Hodo** is the recipient of the 1999 University of Maryland (UM), Baltimore County, James Partridge Award for the Outstanding African American Information Professional. Simmons-Hodo is the head of reference at UM and has worked for the library in various positions for the last 25 years. Simmons-Hodo is active in professional associations including serving as secretary for the Black Military History Institute of America and a member of the Maryland Library Association.

**Michael David Rusk** is now editor of the *Community & Junior College Libraries* journal. Rusk is dean of the Learning Resources Centers at Tulsa Community College in Oklahoma.

**Iren L. Snavelly Jr.**, librarian at Temple University's Harrisburg, Pennsylvania, campus, is now editor of the *Journal of Religious & Theological Information*.

**Leon Stout**, Pennsylvania State University (PSU) archivist, has been elected vice president/president-elect of the Society of American Archivists (SAA). Stout has been PSU's archivist since 1974. He was named a Fellow of SAA in 1996. He has also served as treasurer of SAA and chair of the Description Section and Archival Educators Roundtable. Kaufman is currently on the editorial board of the *Journal of Library Administration*. She has served as consultant to a dozen university libraries. In 1989, she won the UIUC-sponsored Robert B. Downs Intellectual Freedom Award.

**Lee C. Ketcham-Van Orsdel** has been appointed director of libraries at Eastern Kentucky University (EKU) in Richmond, Kentucky, effective August 1. Van Orsdel comes to EKU from the University of Montevallo in Alabama, where was director of libraries since 1991. ## Retirements

**Eva Jonas**, librarian of the Museum of Comparative Zoology at Harvard University (HU), has retired after 30 years of service to HU. She began her career at HU as a lab assistant in the Biological Laboratories after leaving her native Czechoslovakia. In 1973 Jonas was named head teaching assistant in Biology in the Summer School and also appointed reference librarian in the Cabot Science Library. In 1975 she became associate of Adams House (an academic house where students, faculty members, and tutors live), and in 1990 became its acting master. She was appointed librarian of the Museum of Comparative Zoology in 1978 (later named the Ernst Mayr Library of the Museum of Comparative Zoology).

**Henry Latzke** has retired as director of library and media services at Concordia University in River Forest, Illinois, after 39 years of service. Latzke joined Concordia's faculty as assistant librarian and director of audiovisual services in 1960 and became director of library and audiovisual services in 1971. During the 1970s, he was president of LIBRAS, a consortium of

private liberal arts colleges in the Chicago area. He also served as president of Private Academic Libraries in Illinois and held office with, or served as a committee member for the Metropolitan Library Assembly, the Suburban Library System, the Illinois College and Research Association/Illinois Board for Higher Education Liaison Committee, and the Illinois Library Computer System Organization. Latzke has been recognized by the Lutheran Education Association with the Ellen Waldschmidt

Service Award for his lengthy service to the organization. He has also received the Mel George Award from LIBRAS for outstanding work in promoting library cooperation.

**Eva Steiner Moseley** has retired as curator of manuscripts at the Schlesinger Library after 27 years of service to Radcliffe College. Moseley emigrated from Vienna in 1939 and completed her studies in the United States. From 1955–71 she held various library and editorial positions. She came to the Schlesinger Library as manuscript assistant in 1971 and was appointed curator a year later. In the early 1970s, Moseley led the library's efforts to discover, collect, and make accessible sources for women's history. She also helped to create the Harvard/Radcliffe Archives Group (1979), founded the Boston Archivists Group, was newsletter editor and president of *New England Archivists*, was Fellow of the Society of American Archivists in 1987 after serving on its council, and she helped found the Academy of Certified Archivists. Her articles have appeared many publications including the *Radcliffe Quarterly* and the *American Archivist*.

**Miriam Palm** has retired from her position as principal acquisitions librarian at Stanford University (SU). She began her career at SU 27 years ago when she was hired as a librarian in the Catalog Department. She has trained many staff members in procedures designed to ensure solid service, and she is a trusted liaison to the collections and public service programs.
