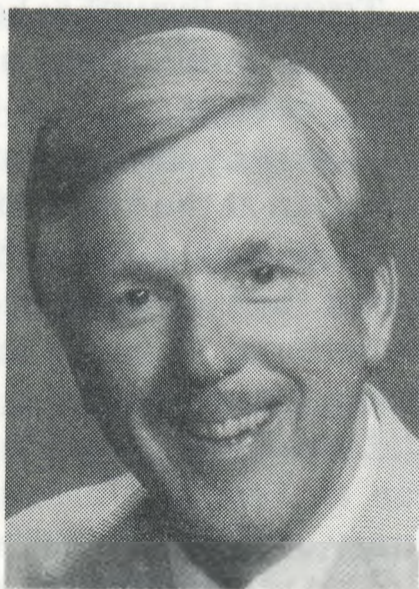
JACK PERRY BROWN has been named executive director of the Ryerson and Burnham Libraries of the Art Institute of Chicago, effective January 3.

Since 1977 Brown was head librarian at the Cleveland Museum of Art. From 1972 to 1977 he was a librarian and photograph archivist at the Yale Center for British Art at Yale University. In 1971-1972 he worked in various capacities for Yale University: as librarian for the Yale University Art and Architecture Library, for Yale's Development Department, and as subject and language specialist for the Slide and Photography Collection. He received his bachelor's degree from the University of Missouri in 1968 and an MLS from Columbia University in 1972.

PEARCE S. GROVE has been named director of libraries for Colonial Williamsburg, Virginia. In creating the position of director, the Colonial Williamsburg Foundation has decided to bring eleven libraries together under one administration. Grove will be responsible for coordination, planning, and the merger of some units.

Grove comes to this position from the National Endowment for the Humanities, where he has served as program officer for the U.S. Newspaper Project since 1981. In that capacity he launched a nationwide effort to identify newspaper resources, coordinate programs for bringing these resources under bibliographic control, and provide funds for major bibliographic efforts at leading newspaper repositories throughout the country.

Prior to his assignment at NEH, Grove was director of libraries at Western Illinois University (1975-1981) where he had major responsibility for planning and supervising construction of a library building that won three national awards, including one from the American Institute of Architects. Grove was also responsible for library building

projects at Colorado Women's College and Eastern New Mexico University, where he was director of libraries in 1961-1964 and 1966-1975 respectively.

Currently chair of the ACRL University Libraries Section's University Library Statistics Committee, Grove was chair of ULS in 1980-1981. A writer and bibliographer, he edited *Bibliographic Control of Nonprint Media* (1972); the October 1975 issue of *Library Trends* on "Library Cooperation"; and ACRL Publication in Librarianship no. 34, *Nonprint Media in Academic Libraries* (1975). He has also published bibliographies on native American library resources and New Mexico newspapers, as well as reports of oral history projects.—*Edward G. Holley, Dean, School of Library Science, University of North Carolina.*

LAWRENCE J. MCCRANK has been named dean of the library at Auburn University of Montgomery, Alabama, effective October 1.

McCrack received his doctorate in the field of medieval and early modern history from the University of Virginia in 1974, and he holds master's degrees in history from the University of Kansas (1969) and library science from the University of Oregon (1976). Before coming to Auburn, McCrank was senior librarian and head of the department of rare books and special collections at Indiana State University, Terre Haute.

McCrack also taught at the University of Maryland (1976-1981), where he received a certificate of merit in curriculum innovation from the Maryland Association for Higher Education. His other teaching duties have included: visiting professor at the University of Western Ontario School of Library Services (1979); visiting lecturer at the University of California, Berkeley, History Department (1976); and instructor at Whitman College (1971-1972).

His recent publications have included *Automating the Archives: Current Issues and Future Prob-*

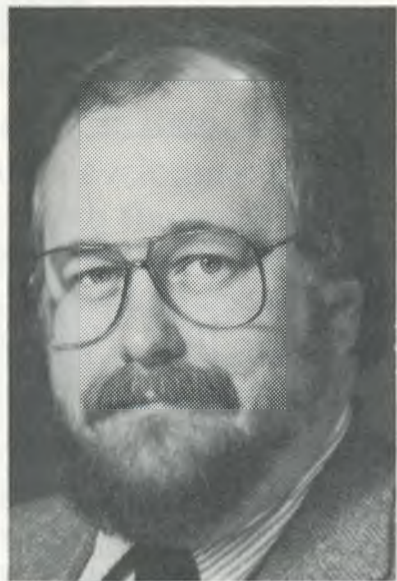

lems (1981) and *Education for Rare Book Librarianship* (1980). In 1977 he was the recipient of the ALA Essay Award.

Permanent paper standard published

The National Information Standards Organization has announced the publication of American National Standard Z39.48-1984, *Permanence of Paper for Printed Library Materials*. The standard is available for \$5 from the American National Standards Institute Sales Department, 1430 Broadway, New York, NY 10018.

This standard establishes criteria for permanence of uncoated papers. Paper which conforms to this standard's requirements for pH, alkaline reserve, and freedom from groundwood is anticipated to last several hundred years in contrast to many of the papers now commonly in use.

NISO expects that widespread adoption of this standard for paper will significantly extend the life of the published record and play a major cultural role in preserving and transmitting ideas, images, and information to present and future generations.

The standard recommends that all publications printed on paper that meets the requirements should carry a statement and symbol of compliance. The symbol is the mathematical symbol denoting infinity set inside a circle.

NCES statistics available

The National Center for Education Statistics has recently published *Library Statistics of Colleges and Universities, 1982 (Summary Data)*. It contains 65 tables which summarize statistics from the NCES survey of colleges and universities in the fall of 1982. There is aggregated data from over 3,000 institutions on topics such as volumes held, number of periodical subscriptions, volumes of government publications held, microforms held, audiovisual materials held, library operating expenditures, salaries of library staff, number of staff, number of interlibrary loans, number of hours the library is open, and number of reference transactions. There is also comparative data from the last time this survey was done in 1979. This publication has 83 pages and is available from the U.S. Superintendent of Documents for \$3.25. The stock number is 065-000-00216-7.

This volume can be used in conjunction with *Library Statistics of Colleges and Universities, 1982 Institutional Data*, which is published by ACRL. This volume is a result of the same survey by NCES and lists the data for the 3,000 college and university libraries which participated on an institution-by-institution basis. It is possible, therefore, to compare the data from a single institution as listed in the ACRL publication with the medians for all institutions in the NCES publication. *Institutional Data* is available from ACRL at a cost of \$12 for ACRL members and \$15 for non-members.
