## See who's running for office

### Vice-president/President-elect

**Paul Dumont** has been the director of educational resources support services at Dallas County Community College since 1998. For more than 20 years (1976–98) he was director of technical services at Dallas County Community College, and, prior to that, he served as the chief of materials processing services at the Dallas Public Library (1974–76). He was also systems/reference librarian at the San Antonio College Library (1969–74) and a reference librarian at St. Francis College in Maine (1968–69).

Among his ACRL activities are service on the Local Arrangements Committee for the Community and Junior College Libraries Section (CJCLS) (1980, 1984, 1989); CJCLS Policy and Procedure Committee (1985–87); CJCLS Awards Committee (1989–90, 1994–96); CJCLS Board (1990–92); Statistics Committee (1988–89); Nominations Committee (1994–95); *College and Research Libraries* Editorial Board (1996–98 and 2002–04); and on the ACRL Board of Directors (1993, 1998–02). He was also Texas representative to the Chapters Council (1985–86) and chair of CJCLS (1990–91).

Dumont has also served the ALA Office of Research and was a member of the NCES/IPED Academic Library Survey Advisory Committee (1992–99).

His activity at the state and regional level has included membership in the Texas Library Association, with service on its Program Committee (1991); College and University Libraries Division (CULD), chair (1996–97); Nominations Committee (1998–99); CULD/ACRL Texas Chapter, (1985–86); Local Arrangements, cochair (1974); Hetherington Profes-

**Frances Maloy** is leader of the access services division at Emory University General Li-

braries, a position she has held since 2001. From 1999 to 2001, she was leader of organization redesign at Emory. In addition, she held the position of head of the circulation department from 1992 to 2001. At Hamilton College, she was director of public services (1983–92) and assistant reference librarian (1982–83).

Her activities in ALA divisions include service on the ACRL 2002 Nominations Committee, of which she was chair (2000–01). Maloy also served as chair of ACRL's Committee on Ethics (2000–03) and was the ACRL liaison to the ALA Committee on Professional Ethics (1997–03). She has also served as a member of the Board of Directors for the Supplemental Funding Task Force (2000–02) and on the Conference Program Planning Committee, Washington, D.C. (1998). Maloy has also been active on the LAMA/LOMS Planning and Evaluation of Library Services Committee (1992–93).

In state and regional associations, Maloy was a member of the University Center of Atlanta, Georgia Consortium: Interlibrary Use Committee (1992–01), a member of the Direct Borrowing Task Force (1992–96), and secretary of the Central New York Resource Council's Professional Development Committee (1982–87). In addition, Maloy has been a member of the Organizational Change Alliance since 1994.

Her publications include "Defending the freedom to read: A reflection of personal values and censorship," *C&RL News* (March 1998).
