Lauren Pressley, director of the University of Washington (UW) Tacoma Library and an associate dean of UW Libraries, is the 81st president of ACRL.

Karen Munro, associate dean of libraries, learning and research services, at Simon Fraser University (SFU), has been elected vice-president/president-elect of ACRL.
