Karen Munro, associate dean of libraries, learning and research services, at Simon Fraser University in Burnaby, British Columbia, on the traditional, current, and unceded territories of the Squamish, Tsleil-Waututh, Musqueam, and Kwikwetlem Nations, is the 82nd president of ACRL.

"Stepping into the position of ACRL President feels like starting any big new job: exciting, inspiring, and a little nervewracking. As I make this move, I'm grateful for the example set by the many talented, thoughtful, and forward-looking colleagues who have preceded me in this role and in member leadership throughout ACRL—as well as the dedicated and terrific staff who do so much to make the association great.

Within ACRL sections she has served as chair of the ACRL Instruction Section (IS) Nominating Committee (2014-16), member of the IS Advisory Council (2013-16), IS member-at-large (2013-15), chair of the IS Conference Program Planning Committee (2010-12), and intern for and chair of the IS Research and Scholarship Committee (2006-07, 2007-08). She served as secretary, vice-chair, chair, and past-chair of the Literatures in English Section (LES; from 2006-07, 2007-10); initiator, chair, and as a member of the LES New Members Discussion Group (2004-08); and member and chair of the LES Section Planning Committee (2003-05). She was also a member of the ACRL Western European Studies Section (WESS) Research and Planning Committee (2003-05) and a member of the WESS 2005 Conference Program Planning Committee (2004-05).

Munro's work with state, regional, and other national associations includes serving as a member and cochair of the Online Northwest Conference Planning Committee (2010-14, 2014-17), member-at-large of the Information Literacy Advisory Group of Oregon (2012-14), the Oregon University System representative on the ACRL-Oregon Board (2011-13), the Librarians' Association of the University of California (LAUC) representative on the University of California (UC) Heads of Public Service Information Literacy Common Interest Group (2006-07), and member of the UC-Berkeley Librarians' Association of the University of California-Berkeley (LAUC-B) "Academic Library 2.0" Conference Committee (2006-07).

Munro received the University of Oregon Libraries Solari Incentive Award in 2014 and was featured as an ACRL Member of the Week in 2009. She received a UC-Berkeley Townsend Center for the Humanities Fellowship (2007); a UC-Berkeley Mellon Library/Faculty Fellowship on Undergraduate Research (2006); the University of British Columbia Library Association, Neal Harlow Prize (2002); a University of British Columbia Graduate Fellowship (2001); a North American Serials Interest Group (NASIG) Student Grant Award (2001); and a Canadian Library Association, HW Wilson Scholarship (2000).

Her publications include: *Tactical Urbanism for Librarians* (ALA Editions, 2017); "Energy Efficiency in the LMS: Faculty Evaluations of a Sustainable Embedded Model," coauthored by Amy Hofer for *Virtually Embedded: Case Studies of Online Embedded Librarianship* (ACRL, 2013); and "Research for Design: Exploring Student and Instructor Attitudes Toward Accessing Library Resources and Services from Course Management Systems (CMS)," coauthored by Merinda McLure for *Communications in Information Literacy* (volume 4, number 1, 2010).

Jon E. Cawthorne, dean of the Wayne State University Library System and the School of Information Sciences, has been elected vice-president/president-elect of ACRL.

Additionally, Cawthorne's work within ALA includes being a mentor for the LLAMA Mentoring Program (2018), a member of both the ALA Nominating Committee (2006–08) and the Office of Diversity Director Search Committee (2007), and serving as chair of the ALA Spectrum Advisory Committee (2006-07) and the ALA Lippincott Award Committee (2006-07). He was a member of the Spectrum Initiative Institute (2004-08 and 1999-2000), and served as a member of the ALA Awards Committee (2003-06) and the Peggy Sullivan Awards Committee (2004–05). He served on the ALA Publishing Committee (2000–02), the 5th National Conference Site Selection Committee (1999–2001), member of the ALA/PLA New Leaders Travel Grant Committee (2001), and the Dr. John C. Tyson Scholarship Committee (1996–99). Cawthorne developed and comanaged the Black Caucus of the American Library Association (BCALA) homepage from (1995–99), served as chair of the 4th National Conference New Member Orientation (1998), and sat on the BCALA Executive Board (1995–97).

Cawthorne's work with state, regional, and other national associations include successfully gaining membership into the Greater Western Library Alliance for West Virginia University (2015) and Wayne State University (2017), serving as board member-at-large of the Greater Western Library Alliance (2015–17), president of the Pennsylvania Academic Library Consortia (2016), cochair of the Michigan Library Association's Special Events Committee (2000), and chair of the Oregon State Library Association's Membership Committee (1996–97).

Cawthorne was a presenter at the Harvard Leadership Institute for Academic Librarians in 2017 and 2018 and was selected for the ARL Research Library Fellows Program (2011-13). He also took part in the UCLA Senior Fellows as a participant in 2007 and a presenter in 2017. He has received the BCALA Advocacy Award (2015). He also received the ALA John Cotton Dana Award for the San Diego State University Library and Information Access for Marketing Spirit of the Land (2005), the "Outstanding 25" San Diego State University for campus and community work Spirit of the Land (2004), and the Outstanding Faculty Award Presented by Office of Multicultural Affairs at the University of Oregon (1997). He serves as an Advisory Board member and faculty for the UNC-Greensboro Diversity Residency Institute. He is also the cofounder of the
