Standards and guidelines

The ACRL Standards and Accreditation Committee has provided the following definitions of standards documents and guidelines documents. The definitions cover service or performance standards, not technical standards.

Standards Documents:

•are comprehensive, covering the range of programs and services provided by a library serving a Carnegie-classified institution;

• define both qualitative and quantitative criteria;

•present goals toward which the profession aspires;

• include statements expressed in relative terms, that is, by relating library performance to norms derived from a reference population;

•guide the decisions and actions of those in the academic community concerned with the planning and administering of library services. *Guidelines Documents*:

• are program or service specific and not comprehensive;

•define qualitative criteria, generally excluding quantitative criteria;

•identify factors contributing to program effectiveness;

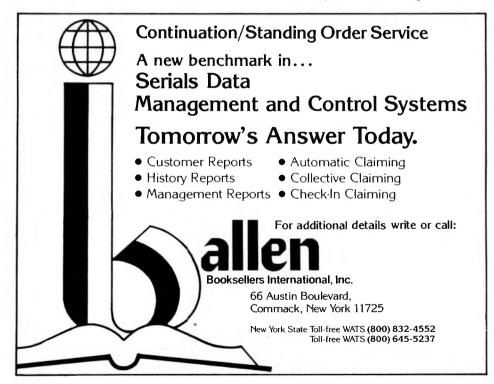
• provide a framework for developing service policies and procedures.
