James Neal receives ACRL's highest honor

James G. Neal, director of libraries at Johns Hopkins University, Baltimore, has been

named the 1997 ACRL Academic/ Research Librarian of the Year. Neal will receive the award (\$3,000 and a citation) at a reception given in his honor on June 30, 1997, 4:30-6:00 p.m., at the ALA Annual Conference in San Francisco, Baker & Taylor Books sponsors the reception and donates the cash award and citation.

In nominating Neal, his colleagues said, "Neal is committed to cutting edge exploration as vital to

the future of libraries. He also retains a sensitivity to the traditional base of libraries. He uses his intelligence, energy, excitement about libraries, and strong people skills to lead and challenge all of us to be better, more effective librarians."


In selecting Neal for this honor, committee chair Ann Prentice said, "James Neal's influence extends well beyond his own institution. He is currently a member of ALA's Executive Board and, in 1996, represented ALA at the WIPO meeting in Geneva. His understanding of the role of the library as key to the process of teaching, learning, and conducting research is broad and encompasses an understanding of the positive uses of technology, the importance of an empowered staff, and sensitivity to the needs and concerns of library users.

"James Neal is persuasive, articulate, and influential as he speaks and writes on behalf of libraries. His outstanding skills, comprehensive knowledge, personal touch, and success in getting things done make James Neal a most worthy recipient of the award."

Neal's career over the past 24 years has included positions as dean of University Libraries at Indiana University (1989-95); assistant dean and head of the Reference and Instructional Services Division at Pennsylvania State University (1983-89); assistant director for Memorial Library public services (1982-83), head of the Collection Management Department (1979-81), and head of the College Library Department (1977-79) at the University

of Notre Dame; and social sciences librarian at Queensborough Community College, City Col-

lege of New York (1973-76).

Neal was also cited for his involvement in a wide range of professional organizations. Within ALA he is currently a member of the ALA Executive Board (1994-2000) and the Planning and Budget Assembly (1995-97) and is cochair of the LITA/LAMA National Conference Networking/Technology Subcommittee and a member of the LITA/LAMA National Conference Steering Committee (1994–97). He has also served on ACRL's C&RL Editorial Board (1990-96), LAMA's Executive Committee (1991-94), and ALA's International Relations Committee (1990-94). Outside ALA he has held positions of leadership in the Association of Research Libraries, the Coalition for Networked Information, the Committee on Institutional Cooperation, and the International Federation of Library Associations.

The Academic/Research Librarian of the Year Award is given annually to recognize an individual who is making an outstanding contribution to academic or research librarianship and library development. Previous winners include: Ralph Russell (1996), Joseph Boisse (1995), Irene B. Hoadley (1994), William A. Moffett (1993), and Carla Stoffle (1992).
