
Retirements

Formerly associate dean at the University of Cincinnati, director of Public Services at Central Michigan University, and head of the Music Library and then assistant university librarian for Branches, Planning, and Systems at the University of Arizona, Dorman has also held positions at Dartmouth, Lawrence University, University of Wisconsin/Parkside, and SUNY Stony Brook.

Deaths

Joseph Barnes, 59, periodicals librarian at Rowan University in Glassboro, New Jersey, died August 14. Barnes had held several positions at the university since 1978, including adjunct faculty member, financial aid officer, and reference librarian. He held leadership positions in the Rowan University Senate and the American Federation of Teachers. He was active in the Tri-State College Library Cooperative, VALE, ALA's New Member Roundtable, and RUSA.

Jean M. Perreault, professor emeritus at the University of Alabama in Huntsville (UAH), has died. He taught at the University of Maryland and was employed in the library at Florida Atlantic University. Twenty-six years of his career was spent at UA, where he

served at times as director and professor of bibliography. Perreault is the author of numerous publications in classification, including Introduction to U.D.C. and Idea of Order in Bibliography. As the first chair of the Council of Librarians of the Alabama Commission on Higher Education, Perreault guided the formulation of academic library standards in the state. His extensive work with archives contributed to his identification of a 1481 Nicholas Jensen imprint while at the Milwaukee Public Library, as well as the discovery at the UAH Library of a volume pamphlets collected and bound by Thomas Jefferson for his own library, sold to the Library of Congress in 1815, and subsequently lost.

Louis Henry Silverstein, who was a librarian at the Yale University Library for 33 years when he retired in 1996, died July 5. Silverstein was a cataloger when first joined Yale in 1963, and in 1970 he became head of the Reclassification Division and supervised the reclassification and re-cataloging of titles in CCL, SML Reference and Bibliography, BRBL Reference, and SSL. Four years later, he returned to rare book cataloging where as principal cataloger, he focused mostly on original cataloging of English titles for Beineicke Library. In 1991, Silverstein cut back on part of his cataloging assignment to become curator of the Arts of the Book Collection. He stepped aside from cataloging altogether in 1995 to devote himself to his half-time appointment in Arts of the Book and retired in 1996.
