A graduate of Northwestern University, Lohf earned an M.A. and an MLS at Columbia and joined the staff of the library system upon graduation in 1952. A fellow of the Pierpont Morgan Library and a council member of the American Museum in Britain, he was also elected in 1990 as president of the Grolier Club.

Three exhibitions at Columbia have been assembled to mark Lohf's retirement. "The Lohf Years" includes 103 rare editions, manuscripts, drawings, and paintings acquired while Lohf was in charge. "A Librarian's Gifts" includes 135 manuscripts, letters, and first editions of English and American authors of the last two centuries donated to Columbia by Lohf between 1958 and 1992. And "Kenneth A. Lohf: A Columbia Career" features photos, books, and papers documenting his library, writing, and collecting careers.

William E. Meneely retired December 1, 1992, after 16 years of service in the Pullen Library at Georgia State University. During those years, Meneely served as catalog librarian, head of the Monograph Cataloging Unit, science bibliographer, and head of the Collection Development Department. His retirement is due to medical reasons.

Deaths

Rolf Erickson, head of Northwestern University Library's (NUL) Circulation Services Department, died on November 2, 1992, after an 18-month struggle with lymphatic cancer. He was 51. A 1962 graduate of St. Olaf's College, Rolf served for two years as a mission teacher in New Guinea and for a year as a high school librarian in Random Lake, Wisconsin. He then earned his MLS at the University of Wisconsin in 1966 and in the same year was appointed administrative assistant to NU's university librarian.
