Retirements

Jean Albrect, head of the forestry library at the University of Minnesota (UM), retired in January after 39 years of service. During her tenure, the library became nationally and internationally recognized for its collections and the four online databases produced by Albrecht-Social Sciences in Forestry, Trail Planning Construction and Maintenance, Tropical Forest Conservation and Development, and Urban Forestry-which started as print publications in the 1970s and early 1980s to provide access to interdisciplinary material and grey literature and have continued to develop and expand since migrating online in 1992. For 15 years prior to her position as forestry librarian, Albrecht was head of departmental libraries on the St. Paul Campus.

William Hannaford has retired as the director of the Eliot Pratt Library at Goddard College. Prior to this position, Hannaford was the library director at four other institutions, including Albright College, Champlain College, and the American Farm School in Thessaloniki, Greece. He has just been designated a Fulbright Senior Specialist and expects to be appointed to a position in Greece, where he will be living.

Penelope Krosch, university archivist at the University of Minnesota Libraries since 1986, has retired; she had been on the archives staff since 1965. In addition to collecting and preserving the archives' collections, she taught history classes about the techniques of primary research and aided researchers in mining the

archives' resources. Krosch edited and transcribed *Shotgun and Stethoscope: The Journals of Thomas Sadler Roberts* (University of Minnesota, 1991). She has been an active member of the Society of American Archivists, Midwest Archives Conference, Twin City Archives, Special Libraries Association, Northern Great Plains History Association, and the Minnesota Ornithological Union. Krosch also served as a consulting archivist for several professional societies.

Virginia H. Parr, reference librarian and bibliographer at the University of Cincinnati, has retired after 20 years of service to the university. From 1973 to 1982, she held several positions at the University of Oregon Libraries. In 1978, she served as founding editor of *Behavioral & Social Sciences Librarians*, a quarterly journal published by Haworth Press.

Patricia Rodkewich has retired from the University of Minnesota after 41 years of service. She started her career as a librarian on the Minneapolis Campus in the Walter Library and moved to the St. Paul Campus as head of circulation. She was also documents librarian for many years. In 1995, Rodkewich created and developed an electronic full-text library of scholarly working papers from departments of agricultural economics across the country.

Mariann Tiblin, bibliographer of Scandinavian area studies at the University of Minnesota Libraries since 1968, has retired. Tiblin was also German and Dutch language and literature bibliographer from 1995 until her retirement. She has been a major proponent of cooperative collection development and has a long and distinguished record of service in the Society for the Advancement of Scandinavian Study, WESS, and the International Federation of Library Associations.

Deaths

Robert E. Cazden, 71, professor emeritus of library science at the University of Kentucky, has died. He was a member of the American Historical Society, the American Antiquarian Society, and the German-American Research Association. He won numerous awards throughout his career and published several books and papers. **Kenneth A. Lohf,** 77, who retired in 1993 after a 40-year career with Columbia University Libraries, died May 9 in New York City

after complications from a stroke. Featured in the *New York Times* upon his retirement for his remarkable contribution to rare book and special collections, Lohf was also a published poet, literary scholar, bibliographer, and collector. As Columbia's Rare Book and Manuscript Library (RBML) di-

rector for 25 years, Lohf's service to the collections doubled their size to a half-million volumes and 26-million manuscript items. Among those were thousands of letters from authors like William Faulkner, James Joyce, Sinclair Lews, and Eugene O'Neill; medieval manuscripts; and a 4,000-year old Babylonian cunneform tablet. During his tenure, RBML underwent a 3-million dollar renovation, the money for which Lohf nearly single-handedly raised. He also served for 20 years as secretary-treasurer of the Council of the Friends of the Columbia Libraries.

Christie Vernon, 78, longtime ALA and ACRL member and Washington Office supporter, has died. Vernon was passionate about library legislative advocacy, political issues, and process. She was a member of ALA's Committee on Legislation, chairing its Privacy Subcommittee, and author of the Chapter Handbook for Committees on Legislation/ Government Relations, which was published by ALA in 1990. On a national level, Vernon was appointed to the National Platform Committee of the Democratic Party on several occasions and served as a delegate to numerous Democratic National Conventions. She was founder of the Peninsula Democratic Women and president of the Virginia Federation of Democratic Women (1992-94). Vernon was the librarian at St. Leo's College from 1986 until her retirement in June 2001. Prior to that, she was director of the library at Thomas Nelson Community College from 1970 to 1986. She also held positions at a number of public libraries across the country.
