### Google indexes invisible Web

Google, which began indexing Adobe Acrobat PDF files in January and now provides access to more than 22 million PDF files, is beginning to include other non-html file types in its Web index. The new file types (Microsoft Word, Excel, PowerPoint, Rich Text Format, and PostScript) "make up a small but important part of the Invisible web, and Google's effort to make them searchable is a noteworthy advance in search engine technology."
