committees that prepared the first college and community college library standards. He has been a library building consultant to more than 40 colleges and universities throughout the United States. In honor of his services to the University of Northern Iowa, the State Board of Regents has named the library building the Donald O. Rod Library.

JOHN A. WITMER will retire in August as director of the Mosher Library at Dallas Theological Seminary, a post he has held since 1963. Witmer joined the Seminary faculty in 1947, teaching in the Systematic Theology department along with his library responsibilities.

Death

FRED CARRINGTON COLE, president of the Council on Library Resources from 1967 to 1977 and a member of its board of directors since 1962, died on May 6 at his home in Chapel Hill, North Carolina. While serving as a special consultant for the Ford Foundation's education program in 1954–1955, Cole began inquiring into the problems facing the nation's libraries. It was in part his awareness of these problems that contributed to the establishment of the Council on Library Resources by the Foundation in 1956.

• Jesuit Science in the Age of Galileo (32 pages,


