Commission and CLR merge

organization will continue to be active in all former program areas: leadership, digital libraries, economics of information, preservation and access, international initiatives, and discussions with scholars. Stanley Chodorow will serve as chairman, Marilyn Gell Mason as vice-chairman, David B. Gracy II as secretary, and Dan Tonkery as treasurer.



There will be a number of Preservation and Reformatting Section (PARS) meetings during the ALA Midwinter Meeting, and because it is taking place in Washington, D.C., many will be held at the Library of Congress. In particular, the Preservation Administrators Discussion Group (PADG) will hold its meeting on Friday, February 14, 2:00-5:30 p.m. in the Mumford Room at LC.
