

McDonald and Lynda Basney Micikas (188 pages, April 1994), takes a cool, hard look at commonly accepted indicators of library effectiveness and the theoretical underpinnings of bibliographic instruction and information literacy. The ACRL performance measures come under some scrutiny in chapter 8. African Placenames: Origins and Meanings of the Names of over 2000 Natural Features, Towns, Cities, Provinces and Countries, by Adrian Room (235 pages, May 1994), reveals the etymologies of African placenames, with appropriate historical, topographical, and biological references. Atlas of Mesozoic and Cenozoic Coastlines, by Alan G. Smith, David G. Smith, and Brian M. Funnell (99 pages, June 1994), is an invaluable source of paleogeographical information. Thirty-one maps, generally corresponding to stratigraphic stages, provide a snapshot of the continents at approximately 8-millionyear intervals and demonstrate the breakup of the Pangaea landmass into our modern continents. An Ethnohistorical Dictionary of the Russian and Soviet Empires, edited by James S. Olson (837 pages, April 1994), provides a complete description of 450 ethnolinguistic groups in the Commonwealth of Independent States. The essays are insightful, offering the history and characteristics of such familiar peoples as the

Cossacks, Jews, and Latvians as well as more obscure ethnic groups. The volume includes appendices on population statistics, a chronology of the Russian and Soviet Empires, and a brief history of Islam in the area. \$125.00. Greenwood Press, 88 Post Road West, P.O. Film Quotations, by Robert A. Nowlan and Gwendolyn W. Nowlan (745 pages, May 1994), identifies 11,420 cinematic quotations in more than 900 subjects. Each quote gives the movie title, production company, year of release, speaker of the line, and, when appropriate, a comment putting the quote in context. There is no subject for libraries, but under "books" there is: "... I'm going to help rebuild the library. And if anybody ever again tries to remove a book from it, he'll have to do it over my dead body" (Bette Davis in *Storm Center*, 1956). \$77.00 postpaid. Historical Atlas of Colorado, by Thomas J. Noel, Paul F. Mahoney, and Richard E. Stevens (192 pages, August 1994), offers sixty black-and-white maps on topics of historical and geographical significance, among them territorial disputes, water diversions and reservoirs, stage-coach lines, lost mines and buried treasures, Native American tribes, and literary locales. Latin Literature: A History, by Gian Biagio Conte (827 pages, April 1994), is a definitive

survey of Roman writing from the early Republic to the dawn of the Middle Ages. This encyclopedic work can be used as a reader's handbook, a bibliographic guide, a literary study, or a supplement to the philosophies and politics of the ancient world. Conte. Italy's preeminent Latin scholar, gives equal time to Latin chronicles, oratory, poetry, creative writing, prose, and letters. Written for personnel librarians and others who are responsible for assimilating new employees into the library staff, this manual presents a menu of program activities that can be tailored to suit the needs of many libraries. \$39.95. U.S. Government Periodical Index, vol. 1, no. 1 (quarterly, March 1994—), available in print, CD-ROM, and MARC-tape versions, provides access to articles with significant research, reference, or general interest value from some 170 federal periodicals. Not included are most titles appearing in the Periodicals Supplement to the GPO Monthly Catalog and those covered by CIS' *American Statistics Index*. The single index is alphabetical by subject and name. Print and CD-ROM editions are \$795.00 each, with a combined price of \$995.00. Con-

World History, by Bruce Wetterau (1,173 pages, April 1994), is a dictionary of 10,000 important people, places, and events from ancient times to the present. With this many listings in one volume, most descriptions are brief and concise. with the exception of the entries for countries, which feature helpful chronologies. Art, literature, science, and philosophy are well represented, and there is an emphasis on American history not found in compara-

The 7,500-entry Larousse Dictionary of World History, edited by Bruce P. Lenman (996 pages, 1994), has a few maps and dynastic tables, unlike Wetterau's volume, and the listings are longer.
