## **RBMS** Exhibition Catalogue Awards

Three annual awards for the best catalogue published by American or Canadian institutions in conjunction with exhibitions of books and/or manuscripts will be granted for the first time in the Spring of 1986. Catalogues published between January 1, 1983, and August 31, 1985, are eligible and must be submitted by September 30, 1985, to the ACRL Rare Books and Manuscripts Section's Committee for Awards for Exhibition Catalogues.

The entries will be divided into three budget categories: expensive, moderately expensive, and inexpensive, based upon the production costs of the catalogue, thereby allowing institutions of similar publishing resources to compete within the same category. Catalogues may be of varying formats, styles, and scope, but each must represent, either comprehensively or selectively, an exhibition which has taken place. Criteria for selecting the winners will include the level of accuracy and consistency of presentation in the catalogue, its clarity, quality of design and usefulness to the intended audience. The awards will take the form of printed citations to the institutions organizing the exhibitions.


