

Dale Canelas, director of university libraries at the University of Florida (UF) since 1985, has retired. Having served as the director for 22 years, Canelas had the longest tenure of any library director at the university. Before joining UF, Canelas served as Stanford University libraries director for public services. Her major accomplishments at UF include: established a collection management department and collection management program through which subject specialists direct the acquisition and management of collections and act as liaisons between academic departments and the libraries; established a preservation program to prevent, confront, and repair physical damage to the collections (caused by age, use, heat, humidity, insects, dust, etc.); established a development program to identify friends and raise funds to support the collection and other needs of the libraries; established the Digital Library Center to digitize, preserve, and make accessible electronically resources of the libraries and the university; oversaw the renovation of the Smathers Library (Library East); established the SUS Electronic Resources Committee to provide for statewide consortial pricing, thus reducing UFs costs for electronic collections; oversaw construction and opening of the Marston Science Library to support science, agriculture, and engineering programs; oversaw renovation and expansion of Library West, the main humanities and

social sciences library; created an off-site storage facility; implemented integration of technology with collections and services; and created a human resources ofce. In addition to her accomplishments at UF, Canelas has served as a leader among her professional library colleagues in the state and nation. For ten years she chaired Florida s State University System Council of Library Directors and the Board of Directors for the Florida Center for Library Automation. She served on the Governing Board of the Research Libraries Group. For ten years she served on the Board of the Center for Research Libraries, which provides sophisticated area studies research support for member libraries. She was elected to the Board of the Association for Research Libraries, served as a member of numerous ARL committees, and chaired its Committee on Research Collections. She was an elected member of the ALA's Council and was president of the Library Administration and Management Association.

Sandra (Sandy) K. Peterson, director of Social Science Libraries and Information Services at Yale University Libraries, retired January 31, 2007, after 40 years of service to the profession as government information librarian at the West Virginia State Library, Oberlin College, University of Northern Iowa, College of William and Mary, and Yale University. Peterson is a champion of

free public access to government information; she served in various of ces of ALA including the Government Documents Round Table; as Association of Research Libraries visiting program of cer; and as member and chair of the Depository Library Council to the Public Printer. In 1994 she was awarded the James Bennett Childs Award for lifetime and signi cant contribution to the eld of documents librarianship.

Bernie Sloan, senior library information systems consultant, has retired from the Consortium of Academic and Research Libraries in Illinois (CARLI) after nearly 30 years of service. Sloan has devoted his career to expanding library resource sharing in Illinois libraries, a commitment to be marked by a signi cant milestone this month as I-Share surpasses 10 million resource-sharing transactions since 1979. Sloan joined the CARLI staff well before it was known as CARLI, and even before CARLI's predecessor organization ILCSO (the Illinois Library Computer Systems Organization) became known by that name. Sloan is the author of Linked Systems for Resource Sharing (Boston: G.K. Hall, 1990) and many articles and is a well-known contributor to many library-related electronic forums. He is noted for his work in the areas of resource sharing, and, in recent years, virtual reference service. He was awarded the Illinois Library Associations Hugh Atkinson Award in 1996.

A gray sidebar menu listing other resources travels with users each step of their search. Information listed on this sidebar include links to information about the site and the First Amendment Center, a Supreme Court case tracker, Congressional Research Service reports, guest editorials, regular columnists, including respected Bill of Rights expert and jazz critic Nat Hentoff, as well as a list of experts on First Amendment concerns. There is also a search function.

The information here is current and appears to be updated daily. While not without some political bias to the left of center, First Amendment Center seems to aim for a balanced viewpoint on issues. It is recommended for general users, undergraduate students, and others interested in keeping informed about issues related to some of our most fundamental rights.
