In memory of Donald E. Riggs

Donald E. Riggs, former vice president for information services and university librarian at Nova Southeastern University

(NSU), died Tuesday, February 19, 2008.

He was president of the Library Administration and Management Association (LAMA) from 1994 to 1995 and was instrumental in moving the division forward on a number of fronts.

"Don was a valued colleague," said Ray Ferrero Jr., president of NSU.

"Don will be remembered as the 'architect' of NSU's Alvin Sherman Library, Research and Information Technology Center joint-use agreement with Broward County, the only such arrangement between

a private university and a public library system in the United States.

"He was instrumental in planning the Sherman Library after he joined NSU in 1997.

"Just last year, the university and community celebrated the Sherman Library's fifth anniversary with Don—and I can truly say that this was one of the proudest moments in his distinguished career."

When he retired December 2007 due to poor health, NSU established the Donald E. Riggs Scholarship Fund.
