blood Energy Library at the University Oklahoma, was honored with the Mary B. Ansari Distinguished Service Award during the Geological Society of America's Annual Meeting. The award is given

by the Geoscience Information Society in recognition of significant contributions to the geoscience information profession. Kidd was the geology librarian at the University of Oklahoma for more than 30 years. She specialized in the identification and organization of gray literature important to geoscientists, particularly maps and field trip guidebooks. Kidd's interest in gray literature led to her participation in the development of a union list of Australian field trip guidebooks, published by the Australian Bureau of Mineral Resources, Geology and Geophysics. She also developed a union list of 4,000 unpublished manuscript and archival geological maps of New Zealand, which was published by the New Zealand Geological Survey. Closer to home, she endorsed the Geoscience Information Society's initiative to improve access to guidebooks, serving as a contributor and compiler for the 3rd, 4th, 5th and 6th editions of The Union List of Field Trip Guidebooks of North America.
