Mr. President, Officers and members of the 10th Biennial Session:

Our Laws do not require a report of any kind from this office. Feeling, however, that every officer of this Council should give an account of his stewardship, I submit a brief report in the hope that a kind consideration of the same will prove beneficial to the Order.

Up to date, I passed upon By-Laws and Amendments for forty Branches, of which number about thirty have the official endorsement. The difference in the number passed upon, and those approved is attributable to the fact that some Branches did not resubmit their Laws for approval after being sent back to them by this office for changes and corrections.

This work entails a great deal of time and attention. In but one instance was it not necessary to return the Laws with a request to make same in duplicate. I followed the rule adopted by my predecessor, that all Laws must be submitted in duplicate, in order to retain copy for the files of this office. This, and the many changes and explanations necessary in almost every instance, made my letter not only frequent and voluminous, but my postage account high. In this connection I hope to see the Amendment submitted by me adopted, requiring all Laws and Amendments to be submitted to this office in duplicate.

I have also proposed an Amendment more clearly defining the relation of the sick or relief, to the Branch or Branch fund, than the Law now in existence, and look for its adoption. The major part of the Branches that have relief or sick funds, make it compulsory upon a man to join the relief fund when he becomes a member of the Branch, do not separate their relief fund Laws from

their Branch Laws, and in various other ways ~~complied~~^{conflict} with our Supreme Laws.

There are many Branches operating under By-Laws which have not the stamp of approval. That the By-Laws of every Branch should be submitted to this office, is evidenced by the fact that in many cases, I found some of the most ridiculous attempts to impose obligations upon the members and making fines, suspensions and even expulsion the penalty for non-compliance. One Branch I found making its own Constitution, finding it more convenient to operate under it than under our Supreme Laws. Even State Councils assuming the right to suspend Branches. Arbitrary and Laws inconsistent with the rights of members, and with the Order Laws, showing that the framers are totally ignorant of our Supreme Laws.

Branches should be compelled to submit their Laws for approval, as their interpretation of our rules and the attempt to put into execution their unauthorized Laws will with time cause the Order much trouble and litigation.
